Request to fund replacement of Catskill Building RPZ device and replacement of Caustic Soda Storage Tank

Mr. Geho mentioned that the RPZ device stands for reduced pressure zone double check valve assembly. It is a piece of equipment we have to have on our DAF system per the Department of Health guidelines.

In March the city reduced the flow in the Catskill aqueduct which allowed us to not be able to pump from the aqueduct so we had to shut the plant down. When we shut the plant down, this check valve assembly failed. When we came back online, we had to remove it and put a spool piece in it. We could not operate in a long-term fashion without this piece of equipment. We purchased and installed it in house.

Because this was not budgeted for we are requesting we fund this through the fund balance to cover the overage. This was an emergency to get it done so that we would not receive any violations from the Department of Health. Mrs. Paget asked Mr. Geho if he thought we could transfer money from or to that would cover the cost. Mr. Geho said we may have money at the end of the year from the electrical or chemical budget to cover the cost. Mrs. Paget mentioned that we would run that line negative now and then see where we would land operationally then we can cover it in that manner. Mr. Geho mentioned that the cost of the part was \$9,700.
